#### Backup to the Cloud and Beyond - Real Solutions (Mt. St. Helens B)

Let us challenge your thoughts about backing up files to Oracle Cloud. Every customer should be considering RMAN backups of their databases to Oracle Cloud (if not already). Several Utility Companies have EBS and Edge Applications. The respective Analytical applications, namely Oracle Business Intelligence Applications (OBIA) and Oracle Utility Analytics (OUA) are two separate BI Applications with similar tool-sets. To achieve an actual single-source-of-truth, the two applications require merger and consolidation. This merger is at Logical, Data and Integration Layer.
